She was standing in the driveway --17 18 THE REPORTER: Excuse me, you need to slow down a little bit. 19 20 Α. The side gate to the residence was in the open position. We walked around to the back of the 21 22 residence, the back door had been kicked in. violent crime. It had been kicked several times. 23

- A. There was smudge marks on the door in several places. If I'm not mistaken there's a dog door there, the door had been kicked several times. You could tell the smudging -- I couldn't tell if it was it a hard sole shoe or a tennis shoe.
- Q. When you say it's kicked in, does that mean that it was kicked off its' hinges or to break the lock?
- A. The door and the door jamb as well as door frame were destroyed.
 - Q. Destroyed.
- A. Yes, ma'am.

- Q. Did the house look like it was in disarray?
- A. Yes, ma'am, it absolutely was. It had been completely ransacked, the entire house.
 - O. Describe that for us?
- A. Well, I entered from the rear door, of course, I could see that the things on the bar were all scattered about. The complainant started showing me through the house as I asked her questions and there was a vault in the living room, she had a large amount of papers on the fire vault and they had just been knocked off, thrown all over the house. All of her clothing in her drawers in the master bedroom

- were gone through. Just everything that could be gone through was.
 - Q. Did you take a report there at the scene?
 - A. I did.

- Q. And what kinds of things did you document at the scene?
- A. Of course, she was distraught so she did not know everything that was missing in the house so I left her a supplemental report form, that's standard operating procedure.
 - O. What does that mean?
 - A. What's that?
- Q. You left her a supplemental report, what does that mean?
- A. She started -- of course, she's excited so she's telling me the things that she knows right away that are missing. As we entered the back door of the house, the laptop that was in the dining room was missing, obviously there was a space where it was gone and, obviously, the space where the fire vault, firesafe was, it was vacated. The jewelry box and the good jewelry was gone from upstairs. She knew right away the things, and she was mostly worried that all of her passports, birth certificates, marriage license, all of her documentation had been

stolen.

- A. We always -- I always ask if they suspect someone. Do you have a an ex-boyfriend? I don't go into it to deeply. I ask if they have any idea who did it.
 - Q. Did you ask that in this case?
- A. I did ask Ms. Crozier if she had any suspects in mind and she replied she did not.
- Q. Were there any clues at the scene that you could tell would have been able to help you find out who the burglar was?
- A. I take a lot of fingerprints because I've, obviously, I've been doing this a long time. But there was nothing for me to find at this place. I looked as best I could. If they had come through a window I could have, but I did not find any discernable fingerprints at that location.
- Q. In a kick burglary are you likely to find -- is that going to be foot?
- 24 A. Yes, ma'am.
