1 THE COURT: Thank you. 2 LES MCMULLEN, having been first duly sworn, testified as follows: 3 DIRECT EXAMINATION 4 5 0. (BY MR. BATARSE) Sergeant, would you please 6 state your full name for the record? 7 Α. It is Les McMullen, L-E-S. Last name is McMullen, M-C-M-U-L-E-N. 8 And, sergeant, who do you work for? 9 Q. Houston Police Department. 10 Α. 11 How long have you worked for HPD? 0. 12 Α. Seventeen years. 13 Q. What are some of the jobs or duties that 14 you had while you have been employed with HPD? 15 Α. I worked patrol for four years, various 16 tactical positions, vice division, and supervisor in 17 a gang division. What did you become -- is there a 18 Q. difference between an officer and a sergeant? 19 20 Α. Yes, there is. 2.1 What is the difference? Q. 22 Α. I'm a supervisor of a small squad of 23 officers that work undercover operations. When did you become a sergeant? 24 0. 2.5 Α. 2007.

## Les McMullen - June 3, 2013 Direct Examination by Mr. Batarse

Okay. Now, you said that you supervise 1 Q. undercover officers? 2 3 Α. Correct. And what type of investigations? 4 Q. 5 Any type of investigations committed by 6 gang members, whether it be narcotics, robberies, 7 burglaries. That is mainly what we deal with right 8 now, actually. So, Gang Task Force? 9 Q. 10 Α. Yes. 11 Okay. Do you also assist other divisions? Q. Yes, I do. 12 Α. 13 Q. All right. And, sergeant, just so the jury 14 can know a little bit about you, are you from the Houston area? 15 16 Α. Yes, I am. 17 Do you have -- you grew up here? Q. 18 Α. Yes. Where did you go to school? 19 Q. 20 Α. Actually, on the east side near Lake 21 Houston. 22 Q. Lake Houston. Do you have family here? 23 Α. Yes. Wife? Kids? 24 Q. 25 Α. Yes.

How many kids? 1 Q. Two. Two daughters. 2 Α. How old are they? 3 0. Six and 4. 4 Α. 5 Q. Six and 4. Okay. So, they are hyper. 6 Α. Oh, yeah. 7 Okay. Sergeant, I'm going to draw your Q. 8 attention to -- I want to talk about June 14, 2012. Okay? 9 10 Α. Okay. 11 All right. So, June 14th, were you on duty 0. at that time? 12 13 Α. Yes, I was. 14 All right. What division were you in at that time? 15 16 Α. Central gang unit. 17 All right. And were you a sergeant at that Q. time, as well? 18 19 Α. Yes, I was. 20 Q. All right. Who were you riding with? 21 Officer Gary Rodgers. Α. 22 Q. What were y'all doing? That particular day we were on the east 23 24 side of town, just north of downtown, just working in 25 conjunction with narcotics division and just

conducting narcotic surveillance and narcotic 1 investigations. 2 And we have been over some of the details 3 with the jury. I don't want to get too repetitive, 4 5 but were you in an unmarked or marked unit? 6 Α. That particular day we were in a marked 7 unit and uniform. 8 Q. Who was driving, you or Rodgers? I was driving. 9 Α. 10 Q. Is that because you're the sergeant? 11 Α. Yes. 12 Q. Okay. Now, sergeant, do all HPD vehicles have a video camera on them? 13 Not all of them. 14 Α. 15 Okay. Do all y'all's vehicles have cameras Q. 16 on them? 17 Α. No, they do not. 18 Q. Okay. Is that a decision you make, or is that a decision that HPD makes? 19 20 Α. City council. It's a money issue. 21 City council. Okay. Q. So, do you determine which car you 22 23 drive? 24 Α. Yes, I do.

Okay. So, do you get to choose or --

- Yes. We have three -- three marked cars 1 Α. assigned to our unit. 2 Okay. So, you have three cars. And are 3 any of them with video cameras in them? 4 5 No, they are not. Α. 6 Q. Okay. All right, sergeant. What was 7 y'all's job that day? 8 Α. We were what you would call like the marked 9 patrol for the narcotic guys. They are riding around 10 in plain clothes in unmarked vehicles. Once they

- A. No. We generally sit anywhere from two to four blocks out of the way, out of the area, because we don't want to have a marked unit in the area, you know, their investigation.
- Q. And who was the undercover officer working that day?
  - A. Officer Lara.

He communicated that he had seen a vehicle 4 Α. come into the parking lot, meet with several males, 5 6 and pull out and then go northbound on Elysian. 7 All right. And, sergeant, I'm going to ask 0. 8 you, what is it that you're referring to in front of 9 you? This is our police report here. 10 Α. 11 Okay. And is that a copy of the police Q. 12 report? Yes, it is. 13 Α. 14 0. And who wrote the police report? Officer Lara. 15 A. 16 Q. Okay. I just wanted them to know what you had in front of you. 17 18 Α. Okay. 19 All right. So, sergeant -- so, he is doing 20 surveillance; and he describes what? 21 He said that he saw a vehicle come through Α. 22 the parking lot, did not enter the store, did not purchase gas, drove through the parking lot, met with 23 24 several males. They came up to him, he had a small

conversation with them, and then they exited without

- making any purchases and went northbound on Elysian.

  did Lara?

  - A. Myself and Officer Rodgers.
- 18 Q. So, did y'all do that?
- 19 A. Yes, we did.
  - Q. All right. How did y'all do that?
- 21 A. We got behind the vehicle, ran the plate
  22 just to make sure that it wasn't stolen or anything.
  23 Once the plate came back clear, we activated
- 24 emergency equipment, lights, and sirens.
- 25 Q. Based on the information that Officer Lara

had given you? 1 Α. 2 Yes. Okay. So, after you initiated the stop, 3 0. did Officer Lara tell you anything else? 4 5 As a precaution, because we never know who 6 we're driving up on or walking up on, generally --7 while we get behind the suspects, generally, 8 undercovers will get in a position next to the 9 vehicles that we try to pull over so they can have an 10 advantage of seeing what's going on inside the 11 vehicle. 12 As we were activating our equipment, because we also can't see what's going on in the 13 14 vehicle, he stated that the driver was going towards the center console and looked very nervous as we were 15 16 trying to pull him over. 17 Did he say that the passengers were doing that, too? 18 19 Α. No. 20 Q. Did the defendant pull over? 21 Yes, he did. Α. 22 0. And did y'all approach his car? 23 Yes. Α. 24 And who approached which side? Q.

I approached the driver's side. Generally,

25

- you want to approach the same side as you are in your patrol car. So, I approached the driver's side.
- 3 Officer Rodgers approached the passenger.
  - Q. And what did you observe, if anything, the defendant doing inside the car?
  - A. Looked as if he was fumbling with his center console.
  - Q. Okay. So, what did y'all do?
- 9 A. Well, just for safety reasons, I asked him
  10 to step out -- asked him for his license, insurance,
  11 asked him to step out of the vehicle. Officer
  12 Rodgers then had the occupant -- the passengers step
  13 out, as well.
  - Q. Okay. So, all three of them were taken out of the vehicle?
  - A. Correct.

- Q. Did you have an opportunity to briefly talk to the defendant?

- Q. Okay. So, you physically looked inside the console?
  - A. Yes, I did.
- Q. Okay. What did you find inside the console?
  - A. Appeared to be like some prescription -- prescription -- like pharmacy pads or whatever, the prescription pads.
    - Q. Okay. Officer -- pardon me.
- Sergeant, I want you to take a moment to go through State's Exhibits 1 through 15. Just briefly thumb through them.

- 25 Q. And tell us if these are the papers that

you found in the center console. 1 Yes, they are. 2 Α. 3 0. Okay. You can go through all of them. All right. 4 Α. 5 Yeah, this is all of them. 6 Q. Okay. I'm not real familiar with the new laws 19 Α. 20 concerning pharmacy, pharmaceutical, any type of crimes dealing with that. So, I had Officer Lara 21 22 come to the scene. 23 Q. Officer Lara -- had he left at that point 24 then?

He was within a block away. He had -- once

Did he walk back, or did he drive 6 back? 7 He parked about a block away and walked 8 onto our scene. Okay. And did he talk to the defendant? 9 Q. 10 Α. Yes, he did. Q. Did y'all have an opportunity to talk to 11 12 the people who were in the car? 13 Α. Yes, I believe he talked to all of them. 14 Did you talk to the defendant and some of 0. the people in the car, too? 15 16 Α. No. 17 Okay. And these prescriptions or Q. prescription forms, did you notice whether or not 18 19 they are written out to the defendant? 20 Α. No. They were different -- various names, and some of them weren't even filled out completely. 21 22 0. Okay. Actually, some of these aren't even filled 23 24 out to a name at all, except for the pills.

So, this idea that you need consent to search, is that accurate? 21 22 Α. No. Is it -- is it nice if someone gives 23 Q.

- Q. I was actually confused that you told them the defendant had his hands up when you walked up because you said he was fidgeting. Can you explain that to the jury?

  you're in his driver's seat --

- **Q.** -- and that side --
  - A. I mean, as -- just for safety reasons, when you approach the vehicle, like I said, you don't know what you are walking up on. So, you're constantly scanning the area at an angle; and I could see that he was fidgeting with his -- and a lot of times it could be anything. It could be -- you can be grabbing for your insurance card. That's where most people keep the insurance. So, it's nothing to be alarmed at, but it is something to take note of what they are doing.

## Les McMullen - June 3, 2013 Redirect Examination by Mr. Batarse

So, I'm keying in on what he is doing. 1 And as I approach him, you know, he had done fidgeted 2 and he turned towards me and he had his hands up. 3 So, I mean, as I'm at his door, no, he is not going 4 5 through fumbling. Nobody would let you do that. 6 That is just not safe. But as I get up to him, he 7 raises his hands. 8 Q. Okay. So, then as you -- so, I mean, 9 actually draw me -- can you step down? 10 Α. Sure. 11 Okay. Let's say --Q. This is the driver. 12 Α. This is the driver's seat? 13 Q. 14 Α. All right. This is the passenger seat. 15 Q. 16 Α. Right. 17 Okay. When he is fidgeting, you're coming Q. 18 up on which side? 19 Α. I'm coming up on the driver. Of course, 20 when you're approaching, you're not going to approach directly behind because you can't see until you get 21 22 right here. I mean, they teach you that in the basic 23 academy. You're going to come out a little further 24 so you have a better angle and you're able to see

25

inside the vehicle.

And as I'm approaching about -- I'd say about right here (indicating), you can see that he was turning and fidgeting, I guess, up to his window. And now I'm about right here (indicating), almost even.

Q. Let's move that.

- A. He has his hands towards me. But, yeah, you want to approach a little further out at an angle so that you have a better angle to see what's going on in the vehicle. Because if you approach right up next to the vehicle, you really can't see them until you're about right here (indicating.) Well, now you're too close.
- Q. Okay. So, by the time you get to him sitting right here (indicating), he puts his hand up when you get up there?
- 17 A. Right.

- Q. Okay. And then at that point, did you ask him to step out?

  - A. Well, like I said, I mean, anybody reaching in that console, they can just be reaching for the insurance card. But you take everything together and make the best decision you can make at the time, you know; where you're at, what time it is, you know, what you can see, what you know, who you're dealing with, where you're working. I mean, there's many factors to deal together.

What are you trained to look for when you 1 Q. 2 approach a car? Any type of suspicious movement. 3 Okay.
